



Privacy statement

Hawkinge Hurricanes Running Club (HHRC) is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the HHRC Web site and governs data collection and usage. By using the HHRC website and closed Facebook Pages you consent to the data practices described in this statement.

This privacy policy covers the HHRC website; links within this site to other websites are not covered by this policy.

HHRC's site does not knowingly store or capture personal information automatically.

HHRC is committed to protecting your privacy and takes its responsibilities regarding the security of user information very seriously.

The information you have provided to HHRC by means of a membership application form or disclaimer forms are stored on a database for the purposes of recording race results, writing to your home address with club correspondence (such as newsletters, renewals), and distributing Club Emails relating to forthcoming races, or official social events. Only members of the Committee have access to your personal information.

We will never divulge your contact details (such as email address, telephone numbers, or home address) to any other party, other than the HHRC Committee, without your prior consent. In other words, even if another member requests your details, we will first contact you to ask for your authorisation before passing on any information. On completion of Club membership forms you will agree to minimal information being shared with England Athletics - our governing body.

The data we will hold on you will be minimal. Appropriate and necessary – further information can be found within our club GDPR Policy.

Collection of your Personal Information

HHRC collects personally identifiable information, such as your e-mail address, name, home address or telephone number only from submitted forms by users.

Use of your Personal Information and Images

HHRC collects and uses your personal information to operate the HHRC site and multimedia platforms deliver the services you have requested.

You consent to you images being used in multimedia, promotional, local press and posters

HHRC does not sell, rent or lease its customer lists to third parties.

HHRC does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

HHRC Web sites will disclose your personal information, without notice, only if required to do so by **law** or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on HHRC or the site; (b) protect and defend the rights or property of HHRC; and, (c) act under exigent circumstances to protect the personal safety of users of HHRC, or the public.

HHRC Club will always use best policy to secure your personal information from unauthorised access, use or disclosure.
